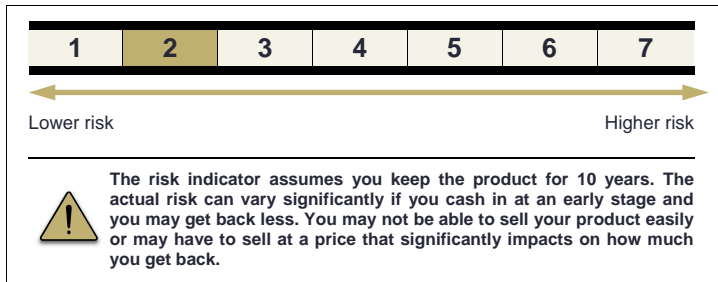
You are about to purchase a product that is not simple and may be difficult to understand.

WHAT IS THIS PRODUCT?

Objectives	Within the investment option Wealins Capitalisation Finland - Investment strategy Conservative 5 at least 95% of the capital will be invested in bonds, money market instruments and / or comparable assets. Up to 5% of the capital will be invested in shares and / or other speculative financial instruments.
Intended retail investor	The targeted investor for Wealins Capitalisation Finland - Investment strategy Conservative 5 has a conservative risk profile and seeks, above all, the safety of his investment through a low risk exposure.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Risk Indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as class 2 out of 7, which is a low risk class. This rates the potential losses from future performance at a low level and poor market conditions are very unlikely to impact our capacity to pay you.

Be aware that your underlying assets may be invested in currencies other than the default currency of, respectively the currency chosen for Wealins Capitalisation Finland and/or the currency of Wealins Capitalisation Finland - Investment strategy Conservative 5. In such case you run a currency risk. This risk is not considered in the risk indicator shown above. Where the underlying assets comprise assets with no or reduced liquidity, transactions may have to be realised over an extended period of time. WHAT ARE THE COSTS?
