
#### Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

Objectives	Wealins Life International is a personal life insurance contract with non-scheduled premium payments and surrenders linked to one or more investment funds.  Wealins Life International is denominated in EUR (default currency) or any other currency chosen by you and accepted by us. You can invest your net premium in the range of investment funds that we make available. These may include both external and internal funds.  An external fund is a collective investment vehicle set up and run by a party other than an insurance company and subject to an approval procedure and ongoing financial supervision by an official regulatory authority.  An internal fund is a segregated pool of assets of an insurance company. Internal funds may be collective, dedicated or specialised insurance funds, and in our case they do not offer a guaranteed return.  An internal collective fund is a fund open to a multitude of policyholders. It is managed in accordance with the investment strategy of the fund and the applicable investment rules set forth by the CAA by an asset manager appointed by us.  An internal dedicated fund is a fund that serves as an investment support to one single contract. It is managed in accordance with the investment strategy chosen by you and the applicable investment rules set forth by the CAA by an asset manager appointed by us.  A specialised insurance fund (FAS) is an internal fund other than an internal dedicated fund that serves as investment support to a single contract. It is managed by you in accordance with your investment profile and the applicable investment rules set forth by the CAA. You may choose between various underlying investment profile and the applicable investment rules set forth by the CAA. You may choose between various underlying investment options according to your investment profile and, where applicable, the chosen investment option, complementing this Key Information Document, which will be provided to you and is also available on our website https://www.wealins.com/en/PRIIPs-KIDs. Intended retail investor	The target investor for Wealins Life International wants an insurance contract governed by Luxembourg law. He is able to invest an initial premium of minimum EUR 50,000 (EUR 125,000 if he wants to invest in an internal fund) and seeks long term performance and the benefits of a life insurance contract (e.g. succession planning, family protection). He is prepared to take investment risks and bea significant losses on his investment, knowing that the value of his insurance contract is subject to fluctuations of the value of the choser funds, i.e. their underlying assets. The targeted investor varies on the basis of the underlying investment options depending on his risk appetite, knowledge of financial markets and past experience.			
Insurance benefits and costs	If the relevant insured person is alive upon maturity of the contract, the insurance benefit is equivalent to the contract value, net of fees. In case of death of the relevant insured person during the term of the contract, the standard death coverage is equal to the contract value, net of fees.  Alternatively, you may choose an optional death coverage (you will find more details under 'Other relevant information'). Wealins Life International does not provide the right to participate in profit-sharing.			
Product Term	Wealins Life International can be subscribed for a specific duration or for the entire life of the insured person (whole of life). In the latter case there is no maturity date and Wealins Life International comes to an end upon death of the relevant insured person. We are not entitled to unilaterally terminate Wealins Life International, unless you have deliberately or fraudulently provided us with false of incomplete information or have omitted to provide us with significant information, or unless the contract value falls below the minimum EUR 50,000 following a partial surrender requested by you.			

### WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

#### **Risk Indicator**



The risk indicator assumes you keep the product for 10 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to sell your product easily or may have to sell at a price that significantly impacts on how much you get back.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as ranging from 1 out of 7 to 7 out of 7 which is from the lowest risk class to the highest risk class. This rates the potential losses from future performance at a very low to very high level and poor market conditions are from very unlikely to very likely to impact our capacity to pay you.

Be aware that your underlying assets may be invested in currencies other than the default currency of, respectively the currency chosen for Wealins Life International. In such case you run a currency risk. This risk is not considered in the risk indicator shown above.

Where the underlying assets comprise assets with no or reduced liquidity, transactions may have to be realised over an extended period of time. The resulting risks of financial losses or other damages are entirely borne by you.

The risk of Wealins Life International may be significantly higher than the one represented in the summary risk indicator where Wealins Life International is not held to maturity or for the recommended holding period.

As Wealins Life International may imply long disinvestment notice periods (for some types of underlying assets) we draw your attention to section `How long should I hold it and can I take my money out early?`.

This product does not include any protection from future market performance so you could lose some or all of your investment.

This product does not hold any capital guarantee against credit risk. If we are not able to pay you what is owed, you could lose your entire investment (see the section "What happens if WEALINS S.A. is unable to pay out?").

### Performance scenarios

The risk and return of the investment varies on the basis of the underlying investment options. The performance of Wealins Life International depends on the performances of the external funds, internal collective funds, internal dedicated funds or specialised insurance funds selected by you. The tax legislation of your state of fiscal residence may have an impact on the actual payout of Wealins Life International. ### WHAT HAPPENS IF WEALINS S.A. IS UNABLE TO PAY OUT?

As there is no guarantee scheme in Luxembourg to indemnify policyholders in case of default of WEALINS S.A. and in order to limit the financial losses that could be encountered by policyholders and/or beneficiaries, the Luxembourg legislation foresees that the underlying assets of insurance contracts are segregated from the own assets of WEALINS S.A. Those underlying assets are indeed governed by custodian agreements previously agreed by the CAA with custodian banks. Through those custody agreements, the CAA has an obligation to control and the right to block those segregated assets. In case of failure of the insurer, the segregated assets are thus protected in relation to the other assets of the insurer and policyholders and/or beneficiaries have collectively the quality of privileged first rank creditors over those segregated assets ranking above all other creditors. This allows them to recover first and foremost all claims related to the execution of their insurance contracts. Policyholders and/or beneficiaries are moreover potentially exposed to the default of a custodian bank with regard to the liquidities deposited with that bank which might be partially or totally lost, whereas it should be possible to recover the securities deposited there in full.

# WHAT ARE THE COSTS?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the product itself and of the investment options, for three different holding periods. They include potential early exit penalties. The figures assume you invest EUR 10,000. The figures are estimates and may change in the future. The costs for the investor vary on the basis of the underlying investment option(s) chosen.

### HOW LONG SHOULD I HOLD IT AND CAN I TAKE MY MONEY OUT EARLY?

#### Recommended holding period: 10 years

You have a period of 30 days from the time when you are informed that the contract has taken effect to cancel the contract by sending us your cancellation letter, accompanied by the policy schedule and any endorsement thereto, by registered letter with acknowledgement of receipt to our registered office. The above mentioned recommended holding period has been defined based on a medium to long-term investment horizon. To obtain certain fiscal benefits in accordance with the locally applicable tax law, the necessary holding period may be shorter or longer. Surrenders are possible at any moment after the expiry of the free cancellation period but may have a negative effect on the performance of the underlying investment option and/or imply potential loss of fiscal benefits associated with insurance products held for the required minimum periods of time. Furthermore surrenders of the insurance contract may be subject to surrender fees (exit costs) and potentially long disinvestment periods for some underlying assets.

# OTHER RELEVANT INFORMATION

Scope of the calculations: The form and content of this document have been implemented in compliance with the requirements of the applicable regulation. All calculations are based on assumptions (holding period, insurance contract and banking costs). The results of those calculations would therefore be different if the policyholder was in a situation differing from the assumptions taken for working out this document.

Optional death coverage: Alternatively to the standard death coverage, you may choose an optional death coverage that is paid out instead of the standard death coverage on death of the relevant insured person. The optional death coverage allows the death benefit to be the contract value net of fees plus a fixed amount chosen by you. The biometric risk premiums for this optional death coverage are not included in the "Costs over time" table but are stated in the General Conditions of Wealins Life International and are deducted from the value of the contract. The optional death coverage is available to all insured persons in good health and can be taken out until the 75th birthday of the eldest insured person. The optional death coverage, if taken out, terminates on the 80th birthday of the eldest insured person and is thereafter replaced by the standard death coverage. In any case, the total amount of capital at risk of all contracts established on the life of the same insured person shall never exceed EUR 1,500,000.
