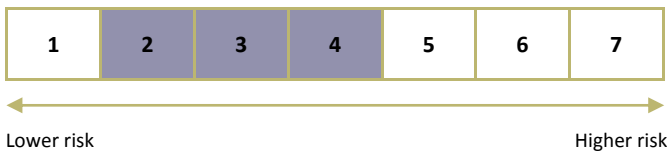

You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type:	Flexi M Luxembourg is an open-ended investment-type life insurance policy, the return on which is linked to internal dedicated funds.
Objectives:	The aim of this product is to allow the policyholder to accumulate savings that are available at any time from payment of flexible premiums and, in the event of death of the Insured Person, to pay capital accrued to the designated beneficiary/aries. Its currency is euro (default currency), or any other currency chosen by you and accepted by us. The investment supports are not guaranteed but are subject to upward or downward fluctuations, depending in particular on the performance of the financial markets. The Specific Information Documents for each of the investment support offered under this product are available upon request made to the company or the intermediary.
Product lifespan:	This contract is taken out for the entire life of the Insured Person. The Contract terminates solely: <ul style="list-style-type: none"> • in the event of termination; • in the event of total surrender; • in the event of death of the Insured Person; • Invalidity pleaded by Wealins S.A.
Intended retail investor:	This product is addressed to Luxembourgish residents willing to subscribe a life insurance contract. This product is suitable for every risk profile, from defensive to aggressive. The minimum investment amount is EUR 125.000.
Insurance benefits and costs:	When the contract ends, Wealins S.A. pays the beneficiary the liquidation value of the underlying assets of the contract. This product does not include any additional death benefits, either mandatory or optional.

What are the risks and what could I get in return?



Risk indicator:

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product between the risk classes 2 and 4 on 7.



The risk indicator assumes you keep to the product for 8 years.

This product involves a risk of capital loss graduated from 2 to 4, depending on the investment choices in the underlying investment vehicles and on the possibility of default by the Company. The policyholder is invited to consult the specific information document of the underlying investment vehicles in order to assess more accurately the risk taken.

If the currency of your payment is different from the currency of the chosen investment vehicle, there is an exchange rate risk corresponding to fluctuation in exchange rates between the currencies, which may affect the return on the investment vehicle.

This product does not include any protection from future market performance so you could lose some or all of your investment.

Performance scenarios

The overall performance of the product depends on the underlying investment options chosen.

What happens if Wealins S.A. is unable to pay out?

As there is no guarantee scheme to indemnify policyholders in case of default of Wealins S.A. and in order to limit the financial losses that could be encountered by policyholders and/or beneficiaries, the Luxembourg legislation foresees that the underlying assets of insurance contracts are segregated from the own assets of Wealins S.A.. Those underlying assets are indeed governed by custodian agreements previously agreed by the CAA with custodian banks. Through those custody agreements, the CAA has an obligation to control and the right to block those segregated assets. In case of bankruptcy of the insurer, the segregated assets are thus protected in relation to the other assets of the insurer and policyholders and/or beneficiaries have collectively the quality of privileged first rank creditors over those segregated assets ranking above all other creditors. This allows them to recover first and foremost all claims related to the execution of their insurance contracts. Policyholders and/or beneficiaries are moreover potentially exposed to the default of a custodian bank with regard to the liquidities deposited with that bank which might be partially or totally lost.

What are the costs?

The reduction in yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs. The amounts shown here are the cumulative costs of the product itself, for three different holding periods. They include potential early exit penalties. The figures assume you invest 10.000 EUR. The figures are estimates and may change in the future.

How long should I hold it and can I take my money out early?

Recommended holding period : **8 years**

The recommended holding period of the contract is 8 years. It depends on the financial situation of the policyholder, his/her attitude towards the risk, the applicable taxation and on the characteristics of chosen product. The policyholder is invited to ask his/her intermediary for advice. At the end of the 30-day cancellation period, the policyholder may at any time surrender partially or totally the contract via a duly dated and signed written request. The partial surrender cannot decrease the value of the contract to less than EUR 125.000 and it must comply with the minimum investment required by the company for each investment fund. The contract ends with the total surrender.

How can I complain?

Wealins S.A. asks that the Policyholder first submit all disputes to Wealins S.A. Management by recorded-delivery registered letter, notwithstanding the possibility of applying to the Commissariat aux Assurances or filing a claim before the courts. The courts shall have sole jurisdiction for all disputes, without prejudice to the possibility of mediation.

It is mandatory that all the documents published on the website be made available under Luxembourg law.
