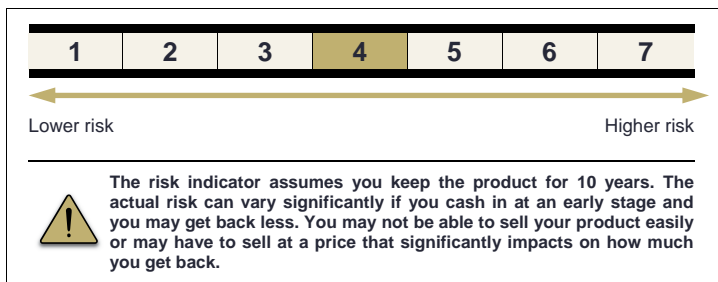
**You are about to purchase a product that is not simple and may be difficult to understand.**

### WHAT IS THIS PRODUCT?

<b>Objectives</b>	Within the investment option Wealins Capi Luxembourg - Investment profile FAS Aggressive between 0% and 25% of the capital will be invested in bonds, money market instruments and/or comparable assets and up to 100% in shares and/or other speculative financial instruments.
<b>Intended retail investor</b>	The targeted investor for Wealins Capi Luxembourg - Investment profile FAS Aggressive is willing to accept the high risk of a strong depreciation of his investment while aiming for a significant increase of his capital and having a sound knowledge of the financial markets.

### WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

#### Risk Indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as class 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level and poor market conditions could impact our capacity to pay you.

Be aware that your underlying assets may be invested in currencies other than the default currency of, respectively the currency chosen for Wealins Capi Luxembourg and/or the currency of Wealins Capi Luxembourg - Investment profile FAS Aggressive.
