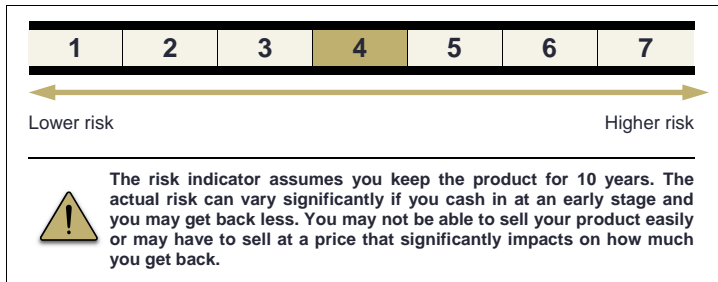

### WHAT IS THIS PRODUCT?

<b>Objectives</b>	Within the investment option Wealins Life Norway - Investment strategy Aggressive 100 up to 100% of the capital will be invested in shares and / or other speculative financial instruments.
<b>Intended retail investor</b>	The targeted investor for Wealins Life Norway - Investment strategy Aggressive 100 has an aggressive risk profile and is willing to accept a very high risk of significant depreciation of his portfolio while aiming for a very significant increase of his capital. This strategy fits investors having an extremely sound knowledge of the financial markets.

### WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

#### Risk Indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as class 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level and poor market conditions could impact our capacity to pay you.

Be aware that your underlying assets may be invested in currencies other than the default currency of, respectively the currency chosen for Wealins Life Norway and/or the currency of Wealins Life Norway - Investment strategy Aggressive 100. In such case you run a currency risk. This risk is not considered in the risk indicator shown above.
