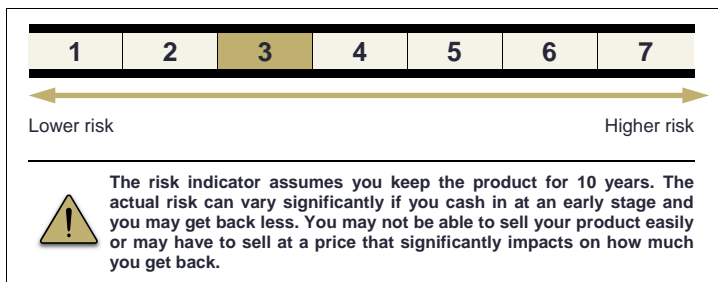
You are about to purchase a product that is not simple and may be difficult to understand.

WHAT IS THIS PRODUCT?

Objectives	Within the investment option Wealins Life Finland - Investment strategy Aggressive 75 at least 25% of the capital will be invested in bonds, money market instruments and / or comparable assets. Up to 75% of the capital will be invested in shares and / or other speculative financial instruments.
Intended retail investor	The targeted investor for Wealins Life Finland - Investment strategy Aggressive 75 has an aggressive risk profile and is willing to accept a high risk of significant depreciation of his portfolio while aiming for a significant increase of his capital. This strategy suits investors having a very sound knowledge of the financial markets.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Risk Indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as class 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level and poor market conditions are unlikely to impact our capacity to pay you.

Be aware that your underlying assets may be invested in currencies other than the default currency of, respectively the currency chosen for Wealins Life Finland and/or the currency of Wealins Life Finland - Investment strategy Aggressive 75.
