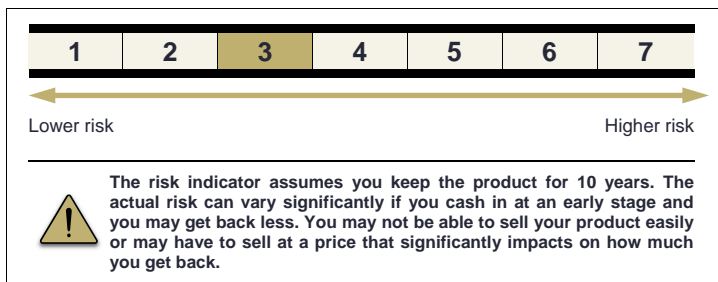
You are about to purchase a product that is not simple and may be difficult to understand.

WHAT IS THIS PRODUCT?

Objectives	Within the investment option Wealins Life International - Investment profile FAS Balanced at least 50% of the capital will be invested in bonds, money market instruments and/or comparable assets and up to 50% in shares and/or other speculative financial instruments.
Intended retail investor	The targeted investor for Wealins Life International - Investment profile FAS Balanced is willing to accept the risk of a significant depreciation of his investment while aiming for a regular increase of his capital and having a sound knowledge of the financial markets.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Risk Indicator
