WEALINS S.A. is committed to protect the right to private life of natural persons with regard to the processing of personal data.

WEALINS S.A. applies the Foyer Group Policy, which is based on and taken pursuant to the Article 24 of the Regulation EU 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data (GDPR).

This policy describes the carried-out processing and the personal data processed by the Foyer Group entities and its insurance subsidiaries. It specifies the purpose of data processing, the storage periods, the cases when WEALINS S.A. may disclose personal data as well as the appropriate technical and organisational measures implemented to ensure the protection of those data.

GDPR provides rights allowing you to control the use of your own personal data. WEALINS S.A. ensures respect for those rights as described in the Foyer Group policy, the latter has appointed a Data Protection Officer involved in all issues related to your data processing carried out by the Group entities.

Those rights include:

- Right of access and control your personal data
- Right to rectification and completion of your personal data
- Right to erasure of your personal data (in compliance with regulatory obligations applicable to data retention)
- Right to restriction of your personal data processing
- Right to personal data portability that means the right to receive your personal data in a structured format.
